#### **Intro - Mitcham Council**

Registration and microchipping of cats encouraged 2010/2011 Then made mandatory 2011/2012 Discount for desexed cats

2.561 cats registered in 2016/2017 Estimated ~ 7.300 in the council\* (35% of cats registered)

No knowledge of effects of cat management of owned cat populations






## Demographics of respondents Sex

## Demographics of respondents Age



## Demographics of cats Management


Most respondents were responsible owners

No difference in proportions of residents keeping cat indoor More Mitcham residents restricted cats outdoor access though






# Respondents attitude to cat registration/bylaws



## "ADELA Respondent in favour of cat management



#### Bylaw/registration vs. council and cat ownership



Nuisance issues – Roaming cats a nuisance


63% of respondents overall had nuisance issues More non-owners (75%) than owners (57%) had nuisance issues 59% in Mitcham and 65% in other councils

#### Nuisance issues roaming cat


Less issues with trespassing and noise in Mitcham for both cat owners and non-owners Non-owners had more nuisance issues than cat owners






#### Nuisance issues roaming cat

Mitcham residents were more concerned with wildlife predation More pronounced for non-owners





#### Nuisance issues cat complaints Mitcham



#### Data from 2010-2017

Registration increased by 46% (1175 - 2561)

Complaints decreased by 61% (95 - 37)

 Statistically significant relationship (Pearson correlation = -0.799, p = 0.03)






#### Potentially fewer strays in Mitcham?






## Feeding a semi-owned cat by cat ownership

## Summing up

Fewer complaints with stray cats in Mitcham – due to cat management?

Indications that there are fewer issues with strays, but no proof that actually fewer stray cats – data limitations

Most owner (respondents) are responsible (desex, microchip)

Majority of residents (respondents) in favour of registration, more so for non-cat owners

Biased sample risk – more responsible cat owners in survey










#### **Cat nuisance by cat ownership**




#### Does your cat go outside? by Council





- Nearly 39% of total respondents not aware cat by-laws introduced
- Majority <u>incorrectly</u> believed cats required to wear a collar, be kept inside after dark, desexed <6 months
- Nearly 85% <u>correctly</u> believed cats must be microchipped
- 92% knew cat registration is required



- 51.2% of cat owners and 73.3% non-cat owners <u>incorrectly</u> believed cats required to wear a collar, (p=0.004)
- 82% cat owners and non-cat owners <u>incorrectly</u> believed cats must be desexed by 6 months (p=0.97)
